NATIONWIDE VEHICLE RENTAL

The State of Montana has signed two Participating Addendums (PAs) under the NASPO Nationwide Vehicle Rental. The addendums allow employees of the State of Montana, while conducting official state business, to rent vehicles at a reduced rate. This applies to both in-state and out-of-state. In-state rentals should be limited to instances where the State motor pool is unable to provide necessary vehicles.

This document represents an overview of the NASPO Nationwide Vehicle Rental. This document is not intended to replace or append the contract, rather to provide an overview and summary of the agreement.

1.0 BACKGROUND

The State of Montana is a member of the NASPO, which establishes the means by which participating states may join together in cooperative multi-state contracting in order to achieve cost-effective and efficient acquisition of quality products and services. This contract is a result of cooperative procurement conducted by the State of Oregon on behalf of NASPO.

2.0 PURPOSE

The purpose of this contract is provide state agencies and all registered cooperative purchasing organizations with an expedited means of obtaining nationwide vehicle rental services.

3.0 NON-EXCLUSIVE CONTRACT

The intent of this contract is to provide state agencies with an expedited means of procuring supplies and/or services. This contract is for the convenience of state agencies and is considered by the State Procurement Bureau to be a "Non-exclusive" use contract. Therefore, agencies may obtain this product/service from sources other than the contract holder(s) as long as they comply with Title 18, MCA, and their delegation agreement. The State Procurement Bureau does not guarantee any usage.

6.0 CONTRACT TERM

This contract took effect on February 16, 2010 and will terminate on October 18, 2017. (Mont. Code Ann. § 18-4-313.)

7.0 CONTRACT RENEWAL

This contract may, upon mutual agreement between the parties and according to the terms of the existing contract, be renewed in one-year intervals, or any interval that is advantageous to the State. This contract may be extended for four renewal periods, if mutually agreed upon.
