

**CONTRACT AMENDMENT No. 2 to

This CONTRACT AMENDMENT No. 2 is to amend the above-referenced Contract, effective July 1, 2012, between the State of Montana, State Information Technology Services Division (STATE), and Gold Creek Cellular of Montana Limited Partnership d/b/a as Verizon Wireless by Cellular Inc. Network, Its General Partner (CONTRACTOR).

The parties agree as follows:

1. PURPOSE OF THIS AMMENDMENT: To amend the following sections of the Agreement:

2.1 Contract Term. The term of the contract is extended for one year, as referenced in section 2 of the original contract. The Contract shall terminate on June 30, 2016 unless terminated earlier in accordance with the terms of this Contract.

6.1 Access to records. The Contractor agrees to provide the State, Legislative Auditor or their authorized agents access to any records required to be made available by 18-1-118 MCA, in order to determine the contract compliance within 10 business days of request or as soon as reasonably possible given the nature and scope of the particular request.



The State reserves the right to designate other State staff to assist in these duties by providing a formal request to the Contractor in advance. 2. TERMS AND CONDITIONS: Except as stated herein, all other terms and conditions of the Contract apply.




