

MASTER SERVICE CONTRACT NO. 2579

AMENDMENT No. 6

ONLINE BOOKING TOOL and FULFILLMENT SERVICES

This is Amendment No. 6 to Master Service Contract 2579 dated 10/16/2012 as amended from time to time ("Master Service Contract") between the State of Oregon acting by and through the Department of Administrative Services, Enterprise Goods and Services Division, Procurement Services ("State" or "DAS PS"), on behalf of the member states of the NASPO ValuePoint Cooperative Purchasing Program ("NASPO ValuePoint") and Participating Entities, and ~~US Travel Alaska LLC~~ dba Corporate Travel Management ("Contractor"). This Amendment is effective upon signature by all the parties and approval as required by law ("Amendment Effective Date").

I. Amendment Purpose. The purpose of this Amendment is to:

a. Term – Agreement is extended through September 30, 2017.

II. The Master Service Contract is hereby amended as follows (new language is indicated in bold and underlining and deleted language is indicated by strikethrough):

4.0 TERM:

4.1 Initial Term. The initial term of the Master Service Contract is three (3) years beginning on the Effective Date unless terminated sooner in accordance with the provisions of this Master Service Contract ("Initial Term"). The Parties may agree to extend the Master Service Contract for additional periods ("Extension Terms") as set forth below, provided, however, the total term of the Service Contract may not exceed ten (10) years from the Effective Date. New expire date is September 30, 2017.

III. Except as expressly amended above, all other terms and conditions of the Master Services Contract are still in full force and effect. Contractor certifies that the representations, warranties and certifications contained in the Master Service Contract are true and correct as of the effective date of this Amendment, with the same effect as though made at the time of execution of the Master Service Contract.

Certification: By signature on this Contract for Contractor, the undersigned hereby certifies under penalty of perjury that the undersigned is authorized to act on behalf of Contractor and that Contractor is, to the best of the undersigned's knowledge, not in violation of any Oregon Tax Laws. For purposes of this certification, "Oregon Tax Laws" means a state tax imposed by ORS 320.005 to 320.150 and 403.200 to 403.250 and ORS chapters 118, 314, 316, 317, 318, 321 and 323 and the elderly rental assistance program under ORS 310.630 to 310.706 and local taxes administered by the Department of Revenue under ORS 305.620.
